



#### Terms and Conditions MRB

1. This raffle is open to everyone that has bought his road tax (Motorrijtuigenbelasting) at Nieuwe Post N.V. between December 1<sup>st</sup> 2011 and February 29<sup>th</sup> 2012
2. There will be a drawing of 5 prizes. The draw will take place on March 5<sup>th</sup> 2012. The prizes will be drawn randomly.
3. The winner of the first prize will receive a reimbursement of the road tax he has paid. The first prize includes also a full year of paid car insurance up to a maximum of NAF. 1500.-.
4. The remaining 4 winners will receive a reimbursement of the road tax he has paid.
6. The result of the draw is final. No correspondence will be entered into.
7. Prizes are not transferable or redeemable for cash.
8. Winners will be notified by post, email or telephone within 48 hours after the draw date.
