



Terms and Conditions Bbuyzzz

1. This raffle is open to everyone that has placed a valid order on www.Bbuyzzz.com between January 1st, 2012 and January 31st, 2012.
2. There will be a drawing of 12 order numbers who will be the winners of 12 prizes. The draw will take place on February 2nd, 2012. The prizes will be drawn randomly.
3. The winner of the first prize will receive NAF. 500,- in cash and a 100% discount on the shipping charges of the winning order.
4. The winner of the second prize will receive NAF. 250,- in cash and a 100% discount on his shipping charges of the winning order.
5. The remaining 10 winners will receive a 100% discount on their shipping charges of the winning orders.
